### Opening Colloguy

#### **B.** Tacony Academy Charter School CEO

a. Mr. Thomas Scheid—Chief Executive Officer of Tacony Academy Charter School

- i. Reviewed and discussed with the Board the June CEO report, previously disseminated to the Board
- ii. Highlight for the Board that Gerald Abernethy has been selected by the Philadelphia Public League as the middle school male coach of the year, and also that the school has been recognized as the first school in country to achieve Level 2 status on the NFHS School Honor roll and Level 3 for coaching.
- iii. Informed the Board of HR changes, including the school's intention to make an offer for a High School principal, contingent on Board approval; that the High School Biology position was re-opened; and that there were vacancies with classroom assistant and lunch monitor vacancies.
- iv. Updated the Board on building operations, including maintenance and repair work; classroom cleanout planning; and various compliance matter.
- v. Informed the Board on Data Curriculum Planning, including the anticipated use of Fountas and Pinnell, Wit and Wisdom, and Eureka Math.
- vi. Informed the Board of a recent forum with Lindley Academy Charter School to discuss inequality and justice issues which provided an opportunity for school community members, upwards of 150, to have an open and safe conversation regarding perspectives and opinions.
  - 1. Board discussed recent actions at the State level to combat inequality.
- vii. Highlighted the end of the year graduation ceremony which had parents/students decorating their cars and driving to the campus.

Advised the Board that water certificates from the city had been received by the school; technical assistant from CEO in developing safety guidelines and protocols; various collaborations with legal to update policies and correct any notices of deficiencies; collaboration with CEO on federal program grant application; and collaboration with CEO and Academic team to develop Health and Safety plans; and
- iii. Informed the Board on upcoming compliance deadlines.
- c. Mr. Scott Kramer—Chief Talent Officer of American Paradigm Schools
  - i. Reviewed and discussed with the Board the June APS report, previously disseminated to the Board.
  - ii. Informed the Board of the utilization of virtual job fairs; that APS updated the Employee Handbook; and that APS had found 3 new hires, though 1 recently backed out so they are actively searching to replace that individual.
- d. Dr. Kristine Magargee—Chief Academic Officer of American Paradigm Schools
  - i. Reviewed and discussed with the Board the June APS report, previously disseminated to the Board;
  - ii. Indicated to the Board that leader training is currently occurring regarding Proactive Leadership, with topics including teacher observations and providing feedback; proactive scheduling and protecting teacher time; clear communications; and courageous conversations;
  - iii. Provided the Board a data update, including a strong intervention program and highlighted ongoing development in various academic areas; and
  - iv. Answered Board questions regarding continuation of education plans
- e. Mr. Gerald Santilli—Chief Executive Officer of American Paradigm Schools
  - i. Informed the Board that APS stands ready to support TACS, whether that is academically, with compliance, or data.

#### E. Business Controller

a. Mr. Peter Costa—Santilli & Thomson, LLC

- i. Reviewed the May 2020 financial report, previously disseminated to the Board
  - 1. Advised that the June payment was for 899 regular students and 176 special education students, and that the school would receive payment based on these numbers for July, August, and September, with reconciliation in October.
  - 2. Advised that IDEA has delayed but should be received soon:
  - 3. Advised that the school had \$5.4M in cash, representating 125 days
- ii. Reviewed the May 2020 P&L report, previously disseminated to the Board
  - 1. Informed the Board that all line items were in budget;
  - 2. Reviewed and discussed summary by class, indicating savings due to school closure in areas such as substitute teachers and transportation;
  - 3. Indicated that \$30,000 had been budgeted for transportation though currently it was over budget at \$110,000, though this variance would be covered elsewhere with cost savings.
    - a. Advised that this increase in transportation cost was a result of SPED matters and when SDP transports students to an APS.
  - 4. Advised on other nominal variances which he indicated were not of significant concern;
  - 5. Indicated that the budget includes money for depreciation, which will result in savings;
  - 6. Highlighted savings in other lines items, such as line 35-37, which will offset transportation costs7.
